

**TERMS & CONDITIONS FOR LENOVO LEGION OF CHAMPIONS SERIES II PROMOTION (The
“Promotion”)**

IMPORTANT: PLEASE READ THESE TERMS AND CONDITIONS (THESE “**TERMS AND CONDITIONS**”) BEFORE ENTERING THIS PROMOTION. THIS IS A LEGALLY BINDING AGREEMENT BETWEEN YOU AND LENOVO TECHNOLOGY SDN BHD (“**LENOVO**”) ESTABLISHING THE TERMS AND CONDITIONS UNDER WHICH YOU ARE ENTITLED TO PARTICIPATE IN THIS PROMOTION. BY ENTERING THIS PROMOTION, YOU CONFIRM THAT YOU HAVE READ AND UNDERSTOOD, AND AGREE TO ABIDE BY, THESE TERMS AND CONDITIONS.

1. Organiser. The Promotion is organised by Lenovo Technology Sdn Bhd.

2. Promotion Period and Submission Deadline:

- Promotion Period (“**Promotion Period**”): 1st January to 31st January 2018.
- Submission Deadline: **9th February 2018 by 6:00PM**

3. Eligibility.

3.1. General Eligibility Requirements

- All residents of Malaysia are eligible to participate in the Promotion.
- If you are below eighteen (18) years of age, you must obtain the appropriate permissions and releases from your parent or legal guardian in order to participate in the Promotion.
- Only individuals are eligible to participate in the Promotion. Groups, organisations and company entries are **not eligible**.

3.2. Not eligible

- The following are not eligible to participate in the Promotion:
 - Employees of Lenovo and its related corporations and their immediate family members.
 - Employees of any party which is directly involved in organising, promoting or conducting the Promotion.

4. Promotion Specifics.

- 4.2. The Eligible Lenovo Product must be purchased within the Promotion Period as indicated in the proof of purchase.
- 4.3. Subject always to Clause 4.5 and Clause 5 for every purchase of any Eligible Lenovo Product, you are entitled to one (1) free Mouse Mat + one (1) free M200 Gaming Mouse, or one (1) free Armored Back Pack + one (1) free M200 Gaming Mouse depending on the product purchased.

- 4.5. Promotion Eligibility
- 4.5.1. To qualify for the redemption of the one (1) free Mouse Mat + one (1) free M200 Gaming Mouse, you will need to purchase any of the Lenovo Legion Y520-15IKBN under the Eligible Lenovo Product and submit your redemption by following the steps in 4.5.3.
- 4.5.2. To qualify for the redemption of the one (1) free Armored Back Pack + one (1) free M200 Gaming Mouse, you will need to purchase Lenovo Legion Y520-15IKBM, or Lenovo Legion Y720-15IKB under the Eligible Lenovo Product, and submit your redemption by following the steps in 4.5.3.
- 4.5.3. Submission:

- Step 2 Upload a scan/photocopy of your purchase invoice/receipt, and a cutout of your purchase unit serial number.
- Step 3 Click Send.
- Via Redemption Form**
- Step 1 Fill in your personal particulars in the requisite redemption form (“Redemption Form”)
- Step 2 Attach a scan/photocopy of your purchase invoice/receipt, and a cutout of your purchase unit serial number (“Supporting Documents”).
- Step 3 Send the Redemption Form and the Supporting Documents via fax, dispatch, post or email with attachment, to the Programme Centre.
- 4.5.4. The redemption in Clause 4.5.1 is limited to the first **1,400** eligible submissions; redemption in Clause 4.5.2 is limited to the first **600** eligible submissions. Redemptions will be based on first-come-first served basis and while stocks last.
- 4.5.5. Each customer is entitled to a maximum of 2 redemptions only.
- 4.6. The latest date and time of submission must be received by the Programme Centre on the **9th February 2018, by 6:00PM.**
- 4.7. You must provide the requested personal information. Incomplete submissions will be discarded without prior notice. An incomplete submission is a submission which does not have a completely filled Redemption Form, without Supporting Document, or have incomplete details in the Supporting Document (without purchase item, quantity, serial number, invoice number, or invoice date).
- 4.8. You must retain your original paid invoice and/or receipt as proof of purchase. End-User/Purchaser may be required to present original proof of purchase when receiving their gift.
- 4.9. This Promotion is not valid in conjunction with any other on-going promotions, offer and/or discounts, unless otherwise stated.

6. How gifts recipient will be notified.

- 6.1. The eligible recipients of the gifts will be informed by phone or email by the Programme Centre.

7. Claiming a gift.

- 7.1. Gift recipients may be required to sign and return a Declaration and Release Form which, among other things, releases Lenovo, the sponsor of the gifts, its respective subsidiaries and associated companies, agents, including advertising and promotional agencies, from all liability relating to the Promotion, and acceptance and/or use of the gifts and confirms his/her compliance with the terms and conditions applicable to the gifts.
- 7.2. Gifts will be delivered by courier to recipients by the Programme Centre within 6 weeks from the Submission Deadline. Recipient or its representative must be present at the Mailing Address provided to accept delivery of the gifts.
- 7.3. Lenovo shall not be responsible for any additional charges incurred (including but not limited to charges for 3rd-party collection, delivery, insurance, etc) to customers who fail to receive the gift either by means of address error by the customer, or is physically absent during delivery, or choose to make special collection arrangements or pick-up services.
- 7.4. Gifts that are not delivered within 3 attempts will be forfeited without prior notice.

8. Redemption form.

- 8.1. Lenovo is not responsible for any printing or typographical errors in any materials or for registrations, redemption form or submissions that are illegible, incomplete, lost or misdirected, fail to enter into the processing system, or are processed, reported, or transmitted late or incorrectly or are lost for any reason including electronic, computer, telephone, paper transfer, mail system, human or other error; including inability to access any website associated with the Promotion. Proof of submission shall not constitute proof of receipt by Lenovo.
- 8.2. If any information provided on a redemption form is found to be misleading or inaccurate, that entry shall be deemed invalid.

- 9. Goods as gifts. Where the gifts under the Promotion are items/goods, they shall be subject to availability and may not be substituted for cash. Lenovo reserves the right to offer an alternative gift of similar monetary value, without prior notice. To the maximum extent permitted by law, you undertake to indemnify and keep Lenovo and its parent company, affiliates, related corporations, subsidiaries, directors, officers, employees and agents harmless and indemnified against any loss, damage, claims, costs and expenses which may be incurred or suffered by any or each of them due to your breach of any of these Terms and Conditions and/or arising from your participation in the Promotion, and/or your use of any gift.
- 16.** Lenovo's decision is final and binding. - 17.** No cheating tolerated. You acknowledge and agree that no form of cheating will be tolerated. If you are found cheating, as determined in the sole and absolute discretion of Lenovo, you will immediately be disqualified from the Promotion. 18. No waiver. Lenovo's failure to enforce any provision of these Terms and Conditions shall not constitute a waiver of that or of any other provision.
19. Modification of these Terms and Conditions, etc. Lenovo may modify these Terms and Conditions and/or withdraw or terminate the Promotion at any stage without any liability towards anyone.
20. All information is correct at the time of publishing. In the event of any inaccuracy or any discrepancy between the print and online versions, the online version shall prevail over the print version.
21. Severability. Each of the provisions of these terms and conditions apply to the maximum extent permitted by applicable law. If a court holds any provision of these Terms and Conditions to be illegal, invalid or unenforceable, the rest of these Terms and Conditions will remain in effect and these Terms and Conditions will be amended to give effect to the eliminated provision to the maximum extent possible.
22. Laws. The Promotion shall be governed by and interpreted in accordance with the laws of Malaysia. The Promotion is void where prohibited or restricted by law, and is subject to all applicable laws.
